Morzine, France - 18th-24th July 2027 Summer Multi-Activity Adventure Holiday

We are delighted to announce an exciting opportunity for our students, a summer multi-activity adventure holiday in Morzine, in the beautiful French Alps. This unforgettable week-long trip will take place between Sunday 18th July and Saturday 24th July 2027. It will give students the chance to challenge themselves, work as a team, and build lifelong memories in a stunning alpine setting. The carefully designed programme combines adventure, personal development, and cultural discovery — all supported by experienced instructors and school staff with full safety equipment and risk assessments in place.

These activities are a fantastic way for students to develop confidence, independence, teamwork, and resilience, all while experiencing the thrill of the mountains and French culture. The trip will be open to current Year 7-10 students. Students will need money to purchase food for the journey to and from the centre. There will be some key pieces of clothing students will need for the trip which are typically items they would already have at home.

The cost of this trip will be £950 and will be based on 30 students going. If we have 40 students who wish to attend, we will be able to lower the price. Accommodation, meals, and travel are all included in the package.

To secure your child a place on the trip we are asking for a **£75 deposit to be paid by 1st February 2026**.

Students will need some spending money for snacks and any souvenirs they may wish to buy. A full UK passport is required, **if your child will not be travelling on a UK passport it is the parent's responsibility to ensure they have the correct documentation or visa prior to departure**. King Arthur's have the necessary insurances, but you may wish to purchase your own. Details of the school's travel insurance policy can be found in the 'trips and visits' area of WisePay.

We will take student attendance and behaviour into consideration when finalising places on the trip. We reserve the right to withdraw students who do not meet the high levels of behaviour we expect at King Arthur's School.

Once committed to joining the trip and deposits have been paid to the travel company, to secure the bookings of accommodation and transport, we would expect you to pay the remaining balance. If your child changes their mind and **if** we are able to fill the place you will be given a refund. However, if this is not possible then the outstanding balance will need to be paid.
